EXPLANATORY NOTE

In addition, the dentist must have a certain amount of knowledge and skills to identify pathology in urgent therapeutic and surgical conditions, provide first aid, the amount of which will ensure the preservation and maintenance of life till specialized care, learn the full scope of knowledge and skills from the first medical aid to ensure favorable course of further specialized care, remembering the great responsibility of the physician for the patients life.

METHODS OF CONTROL

Medical practice "Patients care" estimates in according to traditional (4-points) and 200 – points scales. Mark for practice consists of sum of points for performing by student of practical skills, that checked by direct Head of practice base (maximal amount – 120 points, minimal – 72 points), and points for final control, that notes during differential credit (maximal amount – 80 points, minimal – 50 points).

During differential credit teacher takes into account the level of knowledge of questions from group "The list of questions that submitted on differential credit".

The points of this discipline convert independently as to scale ECTS as to 4 – points scale. Points of ECTS scale don't convert to 4 – points scale and opposite.

- 1. Determination of the patient temperature and making of temperature card.
- 2. Patients observation on availability of head lice and scabies.
- 3. Methods of the patients transportation.
- 4. Usage of functional bed and providing of appropriate positions to patients in cases of dyspnoe and collapse.
- 5. Determination of pulse on radial arteries, conclusion about it main properties.
- 6. Determination of pulse on the lower extremities, conclusion about main it properties.
- 7. Measurements of the blood pressure, conclusion about it compliance to norm.
- 8. Exploration of breathing in indicative patient, conclusion about it properties.

SUMMING UP OF PRACTICE

Summing results of practice carries out if present all reporting documents, in according to program of practice, and characteristics of the students professional activity during practice, signed by direct and general Head of practice – from base of practice.

Mark for practice consists of the sum of points for presentation of practical skills and points for final control. To final control of practice are accessed all students who got for presentation of practical skills for certain kind of practice at least 72 points, gave report for practice and positive characteristics of general Head of practice (from Medical University).

Final control the students pass on the last day of practice to commission. This commission consists of the Heads (direct – from the hospital, if possible, and general – from University).
